1. Purpose

The purpose of this process is to reserve a corridor, review development on reserved corridors on Rightof-Way for Developers or Business Units utilities network in support to their Project development.

The process carries forward the implementation set forth from the Master Plan in support on its goals and policies towards development, in compliance with the minimum requirements as stipulated in Trakhees – Urban Planning & MEP Services Regulations & Technical Guidelines.

Accordingly, TRAKHEES, as Department of Planning and Development of PCFC (hereby referred to as 'Authority'), takes the role of reviewing and approving Service Authority NOCs within PCFC jurisdiction.

2. Scope

The scope is from the receipt of a request from a Developer or business unit consultants/ contractors and Government Utilities Authorities (i.e. DEWA-E, DEWA-W, Etisalat, DU etc.) for providing or reserving a space corridor and verifying/approving laying of utilities on reserved corridor, verification of data, update of master drawing, review and approval up to issuance done through Trakhees online system.

The Business Units under this scope are, but not limited to Nakheel, JGE, DMC, Limitless and refer to 'Special Development Zone Projects – Dubai World' maps for the development and project areas of these Business Units.

This NOC will be issued for one of the following submissions:

- Utilities Services -Trial Pit NOC
- Utilities Services Corridor Reservation
- Utilities Services Route NOC
- Utilities Services Road Cutting / Drilling NOC
- Utilities Services Digging Permit.

3. Definitions

Corridor Reservation

Process for underground utilities i.e. pipeline of a private company or developer, services or utilities which are not in the Master Developer's Infrastructure Plan



Route NOC Process for underground utilities i.e. pipeline of a private company or

developer, services or utilities which are in the Master Developer's

Infrastructure Plan as reserved corridor.

Digging Permit NOC Process for underground utilities i.e. pipeline of a private company or

developer, services or utilities which are in the Master Developer's Infrastructure Plan reserved corridor or with approved General NOC

Corridor Reservation

Road Crossing NOC Process for underground utilities i.e. pipeline of a private company or

developer, services or utilities which are in the Master Developer's Infrastructure Plan reserved corridor or with approved General NOC

Route/Corridor Reservation which requires road crossing.

Trial Pit NOC Process to identify underground existing condition and existing utilities

services, pipelines etc. to aid in the verification and design for allocation

of proposed corridors for underground works.

BU Business Unit, entities and establishments for which the site plan is to

be provided.

Applicant Party applying for the service (i.e. Project Owner/ Consultant/ Contractor)

4.1 Online Submission (Applicant)

4.1.1 The Applicant may visit Trakhees' website (Planning services)

https://www.trakhees.ae/en/ced/Pages/Downloads.aspx. in order to identify the required service approval stages and submission requirements.



- 4.1.2 Applicant can proceed with online submission (https://online.trakhees.ae) by uploading all required documents, as mentioned in the relevant attached application form (see list below) for the requested services:
 - 4.1.2.1 Application form for Utilities Services Digging Permit NOC
 - 4.1.2.2 Application form for Utilities Services Route NOC
 - 4.1.2.3 Application form for Utilities Services Design Corridor Reservation NOC
 - 4.1.2.4 Application form for Utilities Services Trial Pit NOC
 - 4.1.2.5 Application form for Utilities Services Road Cutting Drilling NOC
- 4.1.3 Helpdesk will review the request by verifying the required documents, and accordingly set status. (Refer below)

Online Submission Status:

- In-Progress submission has been accepted, review in progress.
- More Info Required Applicant to reply to HD's comment/s and/or fulfil HD requirement/s.
- Not Accepted application is not accepted by HD (viz. duplicate submission, wrong service request, applicant request, etc.)

4.2 Technical Review

- 4.2.1 Once accepted by Helpdesk, the submission will be reviewed by the Trakhees Planning Engineer, as per below:
- 4.2.2 Trakhees Engineer will check and review the submitted documents.
- 4.2.3 Trakhees Engineer will recommend for a re-submission if there are comments, and applicant will receive a technical report and must respond to the comment/s in the same submission.
- 4.2.4 If submission is approved, Engineer will proceed further to next step, and will recommend final Fees as necessary.

Online Submission Status:

- Under Technical Review technical review in progress.
- 4.3 Issuance of the NOC / Payment of Fees (if applicable)
 - 4.3.1 After a final review, and as soon as the NOC is ready (for the approved submission), Applicant will be notified thru email, and with the final payment advice (if applicable).



- 4.3.2 Applicant can download the NOC and the approved document immediately:
 - If service fees were not applicable.
 - If service fees applicable, and the applicant's prepaid account balance is sufficient, the system can settle amount, and the NOC can be cleared immediately for download by applicant.
- 4.3.3 If no prepaid account balance available, the Applicant must settle first the fee/s first to be able to download the NOC online.

<u>NOTE:</u> Ensuring sufficient balance in applicant's online account will enable the NOC to process faster.

Online Submission Status:

- Approved Under document preparation.
- Awaiting Final Fee Payment Applicant to settle the final fee in order to download the certificate.
- Documents Ready for Collection documents are now ready to collect/download.
- Completed document has been collected/downloaded and process has been completed.


