#### 1. Purpose

The purpose of this process is to issue DLTM coordinates for Plots / right of way for Developers or consultancy offices/ contractors companies, Business Units in support to their project development.

The process carries forward the implementation set forth as stipulated in Trakhees – Urban Planning & MEP Services Regulations & Technical Guidelines.

TRAKHEES, as Department of Planning and Development of PCFC, takes on the role of reviewing and approving these services, as indicated below:

- Plot Coordinates (PDF / TIFF)
- Right-of-way (ROW) coordinates.

# 2. Scope

The Coordinates drawings shall be issued for one of the following submissions:

- Plot coordinates.
- Right of way (ROW) coordinates (For JAFZA North, JAFZA South and Techno Park (N.I.P.) only)

Planning Section receives the submission only once the consultant/contractor settles the recommended fees/ acceptance by Helpdesk, after which it will be handled by CED's Planning section up to the approval of the request

The Business Units under this scope viz. Dubai World, NAKHEEL, EZW, JGE, DMC, Limitless and PCFC, refer to 'Special Development Zone Projects – Dubai World' maps for the development and project areas of these Business Units.

- 4.1 For information prior to submission, the Applicant has to visit the website (link below) in order to identify service approval stages and submission requirements

- 4.2 Applicant to proceed with online (<a href="https://online.trakhees.ae/">https://online.trakhees.ae/</a>) submission by uploading the required documents as mentioned in the application form <a href="https://online.trakhees.ae/">CPL-F08a</a> for the requested service.
- 4.3 Planning Section's scope starts once the Applicant settles the initial recommended fees / acceptance by Helpdesk, after which it will be handled by CED's Planning section up to the approval of the request.
- 4.4 Upon completion of approval, the Applicant shall receive notification, with additional fees (if any)
- 4.5 After verification of payment, Applicant shall receive a notification through the system to collect/download the requested documents.
