1. Purpose and Objectives

The purpose of this procedure is to describe how the Cancelation Deployment of Aids to Navigation for completing the project by the Marine Traffic Management (NS) Department within DMA.

The objective of this process is to keep all AtoN's in Dubai waters for safe navigation and to comply with IALA standards and as per Dubai Regulations.

2. Scope

This procedure covers applications requests for cancelation of deployment of AtoN in Dubai waters submitted previously of by companies Licensed by Dubai Authorities upon completed project.

Also will cover UAE nationals who need to cancel for deployment of AtoN for the purposed of Fish Heaven and any research of AtoN within Dubai waters..

4. Procedure

4.1. Applying for Cancelation of AtoN Approval Certificate

- 4.1.1. Aid to Navigation Owner/Contractor shall fill the Application Form for Deployment of AtoN (DMA-MO-VTN-CF06a), and then submit the application form along with Project Cancelation Certificate to <u>MTM.DMCA@DMA.ae</u>.
 - 4.1.2. DMA will review if submitted trade license is valid and that there are no suspension/remark on the submitted license and accordingly:

- In case any of the above issues: DMA will request from customer for resolve the faces issue (by email or physically depend on the submission channels).
- In case no issues found, DMA review the application.

4.2. Application Review

- 4.2.1. DMA will review the application and accordingly :
 - In case of compliance submission: DMA will conduct with the site inspection.
 - Request for more information: in case missing of any of the required documents, DMA will send email to customer with recommendation of the missing/addition documents required. Customer should send the missing/ additional documents for another review.
- 4.2.2. According to the inspection status, DMA will:

- If comments/ unsatisfactory inspection result: DMA will assign timeframe for rectification and send the comments and timeframe to customer. Then customer has to confirm compliance through email. Then DMA will conduct a re-inspection.

- If satisfactory inspection result: DMA should send a confirmation Email to customer confirming the cancelation of the AtoN Approval Certificate

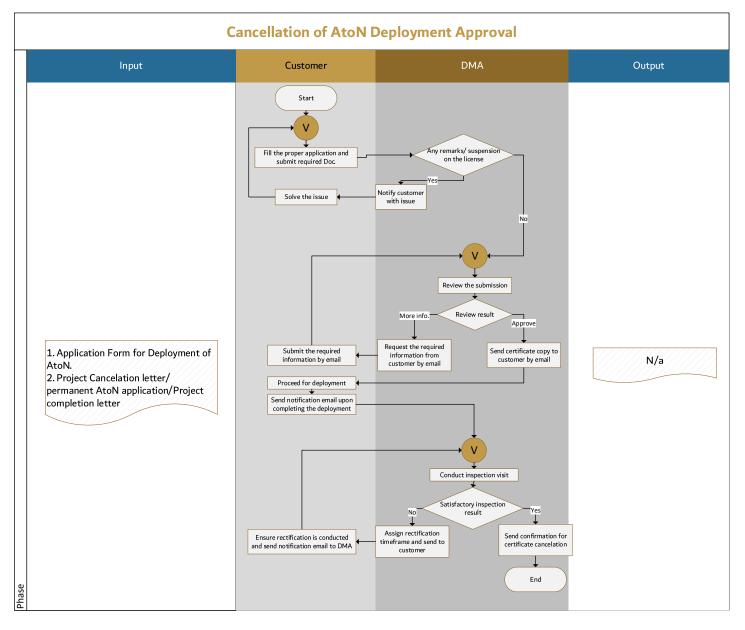
