# 1. Purpose and Objectives

The purpose of this procedure is to provide an outline of the process of how personal licenses are being amended by the Registration And Licensing Section within DMA when requested by the Customer.

The objective is to comply with emirates specific regulations as well as federal regulations specified for issuing and personal licensing.

### 2. Scope

The procedure covers the below amendment types of Marine Driving Licenses and Marine Crew Permits:

- Amendment of Sponsor.
- Amendment of Driving License Sub-category as customer can request to amend the license / permit sub category as per the below

#### 4. Procedure

Service request can be initiated through any one of the following:

- On-line Smart Services System / Mobile Applications.
- Customer can submit a request by directly visiting the 'Customer Happiness centre'

#### 4.1. Application for Amendment of Marine Crew Licensing Validation

4.1.1. Application of this service can be initiated through:

- 4.1.1. Online Smart Services System / Mobile Applications
  - Customer should log on to the smart marine services portal and select Amend marine crew licensing service from the DMA services.
  - System will check for any suspension/ penalties recorded linked to the profile:
    - In case of no suspension/ penalties, customer may proceeds for next steps.
    - In case of suspension; customer should communicate DMA contact centre.
    - In case of penalties, customer can review and pay the penalties via online payment through e-service portal, or contact DMA contact.

Note: Request will not be processed until customer clears all suspensions and penalties as specified above.

- Customer need to fill the required information and amendment type
- Customer should select the marine crew license number.



- Customer then should attach the required documents as mentioned below in table (1).
- Customer to submit the online application.
- 4.1.2. Walk-in Application:
- Customers should visit the DMA 'Customer Happiness Centre' and submit the application along with the required documents as mentioned below in the table (1).

#### 4.2. Application Validation

4.2.1. DMA will review the application and accordingly:

- Approve: in case the application complies with all requirements.
- Request for more information: in case missing any of the required documents, the system will automatically notify the customer through SMS with the application status. Customer can view the missing/additional required documents in the online application and to submit the missing required documents for another review.
- Reject: in case the request does not comply with the requirements, system automatically will notify the customer through SMS with the application rejection. Customer can view the rejection reason in the online application. (Process End)





- 4.2.2. Once the application is as per requirement according to the amendment type:
  - 4.2.2.1. In case the request is for sponsor amendment: Payment advice will be communicated to customer through SMS/ E-Mail, customer should settle the payment as per Payment Process. Once payment is settled, process proceed to Print Marine Crew License (4.3 of this procedure).
  - 4.2.2.2. In case the request is for Sub-category amendment: according license type:
    - For Fishing Driving License: Payment advice will be communicated to customer through SMS/ E-Mail, customer should settle the payment as per Payment Process.
       Once payment is settled, process proceed to Print Marine Crew License (4.3 of this procedure).
    - For any driving license category other than Fishing, DMA will review the application again and accordingly:
      - Approve: Payment advice will be communicated to customer through SMS/ E-Mail.
         Customer need to settle the payment. Then DMA will Print license, process proceed to Print Marine Crew License (4.3 of this procedure)
      - Request for more information: in case of missing any of the required documents, DMA will notify the customer through SMS with the application status. Customer can view the missing/additional required documents in the online application and to submit the missing required documents for another review.
      - Test required:
        - DMA will reply to customer to conduct Practical Evaluation and to contact DMA.
        - Customer should contact DMA and agree on the date and time of the test.
           While:
          - Test date: tests can be conducted on Mondays and Wednesdays. For special cases, request shall be approved by higher management.
          - Test location:
            - For boats up to 12 m : test will be conducted in Mina Rashid/
               Fishermen harbour Umm Squaim, or as per customer request test will be conducted applying evaluation travel fees.





- 12 m and above: test will be conducted in customer boat and customer location within Dubai (without transportation fees) if outside Dubai test will be conducted applying evaluation travel fees.
- At the agreed date, customer should attend the test results will be:
  - Pass: SPL will be communicated to customer through SMS/ E-Mail.
     Customer need to settle the payment. Then DMA will Print license, process proceed to Print Marine Crew License (4.3 of this procedure).
  - Pass with conditions: DMA may request from customer to attend certain trainings as deemed necessary, customer has to attend the requested training. Once the training is attended, SPL will be communicated to customer through SMS/ E-Mail. Customer need to settle the payment. Then DMA will Print license, process proceed to Print Marine Crew License (4.3 of this procedure)
  - Fail: DMA will assign additional training requirements and new date, time and location for the test and notify the customer. Second test will be for free, while any extra tests required will be charged with full test fees.
  - Customer did not show: DMA will contact the customer assign new date, time and location for the test and notify the customer with no show fees which is the full test fees.
- Reject in case the request does not comply with the requirements, DMA will notify the customer through SMS with the application rejection. Customer can view the rejection reason in the online application.
- 4.3. Print Marine Craft Certificate / License:
  - 4.3.1. Electronic Copy of the requested License/ Permit will be sent to customer's Email.
  - 4.3.2. In case customer requested for original copies of the license/ certificates, customer should send a request to the PCFC Contact Centre.
  - 4.3.3. SPL will be communicated to customer through SMS/ E-Mail.
  - 4.3.4. Customer should settle the payment.





#### 4.3.5. DMA will coordinate for certificate delivery.


