## 1. Purpose and Objectives

The purpose of this procedure is to provide an outline of the process of how Marine Craft permits are renewed by the Registration and Licensing Section within DMA when requested by the Client.

The objective is to comply with emirates specific regulations as well as federal regulations specified for maritime activity permit issuing.

## 2. Scope

The scope applies for maritime activity permits requested from:

- DED license or any authority licenses from Dubai
- Marine Craft registered outside Dubai.

## 3. Definitions and Abbreviations

- DED license : License issued by Dubai Economic Department with the following activities:
- Leisure Yachts and boat rental.
  - Jet ski rental.
  - Water sport rental.
  - Club.
  - Institute Training Centre for Boat Driving.
  - Institute Training Diving for Diving.

3.1. DMA : Dubai Maritime Authority.

## 4. Procedure

4.1.1. Customers can visit the DMA 'Customer Happiness Centre' or send email to [RAL.Services@pcfc.ae](mailto:RAL.Services@pcfc.ae) and submit/attach the required documents mentioned below in Table (1).

4.1.2. DMA will review the submission and ensure the availability of the required documents and accordingly:

- Approve: in case the application complies with all requirements, DMA will check if any suspension/ penalties related to the applicant and proceed with next steps.
- Request for more information: in case of missing any of the required documents: DMA will notify the customer through email with the missing/additional required documents. Customer has to submit the missing document for another review.
- Reject: in case the request does not comply with the requirements, DMA will notify the customer through email with the application rejection.

4.1.3. In case of suspension/ penalties, customer should contact PCFC contact center to settle the payment.

4.1.4. Once the application is approved, Payment SPL will be sent to the customer through email, customer should settle the payment as per Payment Process and send copy of the payment receipt to RAL.Services@pcfc.ae.

4.1.5. Once payment is settled, DMA will issue the electronic permit send it to customer through email.
