1. Purpose

Any type of construction activities carried out between 8.00 pm – 7.00 am, within Trakhees' jurisdiction, must obtain Trakhees' NOC for Night Construction Activities.

The purpose of this procedure is to describe and outline the process to clients for obtaining this NOC for night construction activities (applicable between 8.00 pm to 7.00 am), upon inspection and approval by CED.

By ensuring compliance to the developers NOC and conditions, Contractors are permitted to carry out construction activities at night. The timings will be approved only after evaluating existing site conditions / surroundings and any noise pollution complaints.

Accordingly, TRAKHEES, as Department of Planning and Development of PCFC (hereby referred to as 'Authority'), takes the role of reviewing and approving Night shift construction activities within PCFC jurisdiction, to ensure that all safety measures are established and undertaken in line with requirements.

2. Scope

• The scope of the process is from receipt of the application (online submission) for NOC for Night work activities - to the Inspection and issuance of approval for the NOC, within PCFC jurisdiction.

4.1 **Precautionary Notes:**

The below check points (as indicated on <u>Form TRK-CED-CS-CF01a</u>) shall be strictly complied with, prior commencing night activities. Trakhees Engineer / Inspector will inspect for entire compliance before approving

- 4.1.1 Any kind of construction activities which causes High Noise pollution, Vibration & Dust Emission, Environment pollution and disturbance/nuisance to the neighbouring communities/facilities shall not be permitted to be carried out at night time. In case of receipt of any complaint, the Nightshift NOC shall be invalidated immediately and necessary action shall be action, Applicable financial penalty shall be imposed.
- 4.1.2 No night work is allowed on Friday and public holidays.
- 4.1.3 Contractor and consultant shall monitor the ambient noise level recordings regularly.
- 4.1.4 Submit the area survey drawing along with nearby residences, concrete pour plan, pump station, transit mixer route and any information related to noise control procedure.
- 4.1.5 Appropriate machinery and equipment's shall be used to minimise noise level to an acceptable level.
- 4.1.6 Allowable noise limits shall be maintained 30-40 dB during night 8pm to 7 am in residential area.

4.2 Application process

4.2.1 Prior to applying for the NOC, the Consultant/Contractor must ensure appropriate safety measures and compliance to all requirements of Trakhees' Construction Safety Regulations & Standards are met, including applicable

Regulations for Management of environmental nuisance from construction activities (Refer 4.1 precautionary notes above).

- 4.2.2 Prior to applying for the NOC, the Consultant/Contractor must ensure appropriate safety measures and compliance to all requirements of Trakhees' Construction Safety Regulations & Standards are met, including applicable Regulations for Management of environmental nuisance from construction activities.
- 4.2.3 The NOC application must be submitted through online by using <u>online.trakhees.ae</u>, including:
 - Valid Master developer NOC
 - Filled application form (<u>TRK-CED-CS-CF01a</u>)
- 4.2.4 Upon inspection:
 - If site conditions are **in compliance** NOC is granted.
 - If site conditions are <u>not in compliance</u> Applicant needs to comply with Inspection comments before the approval of the NOC is granted.
- 4.2.5 **Validity**: The Night shift NOC shall be valid based on the developer's NOC approved period. Further extension shall be given based on Master developer Recommendations and noise complaint from neighbourhood (if any)


