1. Purpose

The purpose of this process is to ensure that the third party environmental consultants and waste service providers are meeting the minimum requirements and / or expertise in carrying out third party services related to environmental consultancy and / or waste services.

2. Scope

This procedure covers the pre-qualification of the following types of consultants and waste service providers intending to provide third party services to companies and / or for projects within PCFC's jurisdiction.

- Environmental Consultant
- Waste Service Providers

 \Rightarrow Waste Collection and Transport Company

 \Rightarrow Waste Processing Facility

3. Definitions

- 3.1 Environmental Consultant ⇒ Consultants who facilitate the adherence and implementation of Trakhees EHS Standards and Regulations, and carry out environmentally related studies.
 3.2 Waste Service Providers ⇒ An entity that offers services related to waste
- 3.2 Waste Service Providers → An entity that offers services related to waste management, including collection, transportation, treatment, disposal, recycling, and other related activities.

4. Procedure

4.1 Submit request for Pre-qualification application through the Trakhees Online Service (<u>https://online.trakhees.ae/oaservices</u>). Enter relevant login credentials then navigate through the site as per the below:

EHS Customer Service \rightarrow Prequalification / Third Party Prequalification \rightarrow Apply for Prequalification \rightarrow Corresponding Category whichever is applicable – i.e. Environmental Consultant, Waste Collection and Transport Company, Waste Processing Facility \rightarrow fill-up and attach all required details and documents accordingly, then click Submit

Note:

The renewal application submission for Environmental Consultants shall only be accepted one (1) month after the current expiry date; thereafter, only "new" application shall be accepted. No EIA-related submissions shall be accepted from Environmental Consultants with expired Trakhees Prequalification unless their renewal application has already been received and the application date is within the one (1) month grace period provision.

On the other hand, collection permit and / or vehicle pass applications from Waste Collection and Transport Companies or Waste Processing Facilities with expired Trakhees Pre-qualification will only be considered within one (1) month after the current expiry date, provided that a prequalification renewal application has already been submitted.

Ensure that your Trakhees Pre-paid Account has sufficient balance corresponding to the relevant fees as the submission will not push through the online portal.

- 4.2 The online submission shall be reviewed by EHS Environment Section accordingly. If there are any comments and / or documents required for the requested service, a notification shall be received in the Client's registered email address or the current status of the online application can be viewed in the online portal. Client shall respond and / or attach the required document/s through the online portal.
- 4.3 The relevant fees shall be automatically debited from your Pre-paid Account once the submission has been accepted for review. Client may deposit the required amount through any of the following payment channels:
 - Finance Online Services (<u>https://online.trakhees.ae/oaservices</u>)
 - Al Ansari Exchange
 - Bank Transfer (PCFC Dubai Islamic Bank Account)
- 4.4 Corresponding Certificate of Approval (COA) shall be issued once the application is approved. Client can view and download the issued COA in the online portal.
