This procedure covers all companies operating under Trakhees – EHS jurisdictional areas.

4. Procedure

4.1 Waste Exportation

- 4.1.1 Client should submit the below required documents through email (ID.Environment@pcfc.ae)
 - Fully filled-up Basel Convention notification and movement forms
 - Insurance covering the planned shipment
 - List of intended carriers from the point of origin up to the point of destination.
 - Contract between the waste exporter and importer.

- 4.1.2 EHS Environment Section will review the submitted documents and will send copy of payment advice to clients with the status of the submission as below:
 - Approved: once all required documents are available and information complying the requirements of PCFC – EHS. Client should settle the payment and notify the inspection department EHS Environment Section
 - More Details: in case of missing of any of submission requirements or more details
 need to be given by the client. Client should update the required information and
 settle the payment and send to EHS Environment Section
- 4.1.3 Site inspection will be carried out by the EHS Environment Section as deemed necessary.
- 4.1.4 Upon satisfactory inspection and / or application, Department EHS Environment Section will issue the corresponding NOC to client for further action.

4.2 Waste Disposal / Recycling in DM Designated Facilities

4.2.1 Submit request for Industrial Waste Disposal / Recycling through the Trakhees Online Service (https://online.trakhees.ae/oaservices). Enter relevant login credentials then navigate through the site as per the below:

EHS Customer Service \rightarrow Industrial Waste Disposal (Permit) / Recycling (NOC) \rightarrow Apply for Permit NOC \rightarrow fill-up all the details in the fields provided and attach required documents accordingly, then Submit as per below.

- 4.2.2 The online submission shall be reviewed by EHS Environment Section accordingly. If there are any comments and / or documents required for the requested service, a notification shall be received in the Client's registered email address or the current status of the online application can be viewed in the online portal. Client shall respond and / or attach the required document/s through the online portal.
- 4.2.3 The relevant fees shall be automatically debited from your Pre-paid Account once the submission has been accepted either for disposal or recycling. Client may settle the payment advice through any of the following payment channels:
 - Finance Online Services (https://online.trakhees.ae/oaservices)
 - Al Ansari Exchange
 - Bank Transfer (PCFC Dubai Islamic Bank Account)
- 4.2.4 Corresponding Permit / NOC shall be issued once the application is approved. Client can view and download the issued Permit / NOC in the online portal.
- 4.2.5 Once the wastes disposal / recycling has been completed, Client shall attach the relevant proof of disposal / recycling through the Trakhees Online Service (https://online.trakhees.ae/oaservices) as follows:

EHS Customer Service \rightarrow Industrial Waste Disposal (Permit) / Recycling (NOC) \rightarrow Search Requests \rightarrow Click "View" across the relevant Request No \rightarrow Click "Submit Proof" \rightarrow Click "Documents" tab \rightarrow Click "Browse & Upload" button \rightarrow Attach relevant proof of disposal / recycling \rightarrow Click "Next" \rightarrow Tick the box beside "I agree to the above disclaimer" \rightarrow Click "Submit".

Accordingly, the Client shall be notified if further document/s are required or if the relevant waste disposal / recycling application has been closed.
