#### 4.1 NOC Issuance

4.1.1 Client should ensure the availability of enough credits in their prepaid account before applying for the service.

4.1.2 Client should apply on <u>www.online.trakhees.ae</u> and fill up the mandatory fields then submit the application.

- Issue a Driving License (TRK-LD-GS-SF06c).
- Change Driving License (TRK-LD-GS-SF06d).
- Open Bank Account (TRK-LD-GS-SF06e)
- Salary Certificate (TRK-LD-GS-SF06g).
- Consulate Letter (TRK-LD-GS-SF06h).
- Alcoholic beverage permit (TRK-LD-GS-SF06k)
- Adding an Employee as a Partner (TRK-LD-GS-SF06I).
- Company Establishment for Employee (TRK-LD-GS-SF06n).
