## 1. Purpose and Objectives

The purpose of this procedure is to facilitate information to clients regarding the procedural requirements for the amendment of a Free Zone License.

### 2. Scope

This procedure will apply to all Clients within Trakhees' jurisdiction with free zone licence.

## 3. Definitions and Abbreviations

3.1	Company name	-	Is the official name of the person or entity that owns the company. It is the business's legal name usually used on government forms and applications.	
3.2	Trade Name	-	Is a name of business wants to operate under a name oth than the company's legal name. A trade name is different fro a business's legal name. Business owners can use a tra name for advertising and sales purposes. The trade name the name the public sees, like on signs and the internet.	
3.3	Change Company Registration Type	-	The process of changing the legal type of company from FZCO to FZE or from FZE to FZCO.	
3.4	Change Company Legal Type	-	The process of changing the legal type of branches to FZCO or FZE	
3.5	FZCO	-	Free Zone Company, which is a limited liability company with two till 25 shareholders.	
3.6	FZE	-	Free Zone Establishment, which is a limited liability company with one shareholder.	
3.7	LD	-	Trakhees-Licensing Department	





3.8 Advertisement - Announce the amendment to public through Al Bayan Newspaper.

#### 4. Procedure

- 4.1 Amendment of Board Resolutions and MOU (not required for branch license)
  - 4.1.1. According to the type of amendment, customer is required to amend the Board Resolutions and MOU documents as per blow:

- 4.1.2. Once Board Resolutions and MOU amendment is required, customer should approach Trakhees Service Centre requesting for amendment of Board resolution. All the partners company should be available in Trakhees Service Centre with their original passport/ Emirates ID for signing document. Trakhees Service Centre employee should verify the identification of the attendees and make sure that all are presented and witness the signature of all identified people on amended board resolution (and MOU if any). Then Trakhees Service Centre employee should sign, stamp the updated documents and hand it over to the customer.
- 4.2 License Amendment





- 4.2.1. Only in case of Changing Address/ Location, customer should send email to Trakhees.licensing@pcfc.ae and request for update the new lease and attach copy of the new lease contract/ Ejari (if available). LD will update the lease information and confirm to customer.
- 4.2.2. Customer should apply for amendment of a free zone license by submitting the below required documents through online.:

- 4.2.3. LD will check the required documents availability and update the system as follow:
  - Accept: If the submissions comply with requirements, will proceeds with amendment process.
  - Reject: If the submissions not comply with requirements. Applicant can apply again with new submission number.
  - More information: If note any missing document, customer service employee will reject the submission and advice to re-upload the missing information. Applicant should re-upload the requested information with the same submission number.
- 4.2.4. Once the submission is accepted, LD will start the amendment process.
- 4.2.5. Once required external approvals are done (if any), payment advise will be generated and available online to be settled by the client.
- 4.5.1. The client will receive license copy, shareholder certificate, certificate of formation by registered email and Online portal

Note:

- In case of Trade Name/ Company name Amendment, Shareholder change/Legal Type change LD will advertise and announce the amendment in Newspaper Albayan and coordinate to close any comments that might be received against the amendment.


