Operational Requirements for Trakhees under SDZ-PCFC

I/We (name of the authorized signatory) do hereby acknowledge and undertake to comply with all the mentioned conditions/requirements of Trakhees & other relevant Authorities and hereby assure that all activities/operations at the facility (kiosk/shop/warehouse/manufacturing/retail outlets/offices etc.) will be carried out within the scope of the approved license activity.

I/We accept that Trakhees has the absolute discretion to approve or reject the activities requested for and the furnished documents shall become the part of Trakhees records for their easy reference and they may be disposed of in a manner they deemed fit and appropriate.

I/We also understand that Trakhees CED's Modification NOC/Permit is mandatory prior to carrying out any required modifications in my establishment and further information can be obtained from the circular CEDGR-133 using the URL given below.

I/We shall obtain Trakhees CED - Modification Completion Certificate for issued Modifications NOC/Permit which is mandatory prior to starting operation for all the establishments.

I/We shall apply for Activity/Operation verification (NOC-AV/OFC) within a maximum period of thirty days after commencement of my/our business activities.

I/We will be responsible and liable to compensate any loss or damage occurred due to any incident/accident/fire whatsoever during modification works at my/our firm/premises.

I/We also agree to follow the Trakhees Emergency procedures and in case of an Emergency (Fire), I/We will call & report to Dubai Civil Defence (997), for any Accident/Incident Ambulance Services (998) and also notify to EHS Department on 056-6031351.

In case of operational requirements of HEALTH activities, I/We shall liaise with EHS-Public Health Section, for Ports/Marine/Ship related activities, I/We shall liaise with EHS- Ports & Maritime Section and for Industrial Safety & Warehouse related activities I/We shall liaise with EHS-Operations section to comply with the requirements for obtaining NOC/OFC. All the Environment related requirements for any activities, I/We shall liaise with EHS Environment Section accordingly.

Activity Verification Compliance of applicable Retail facilities, in line with the Operational Requirements for Trakhees will be issued/renewed automatically along with the trade license.

Failure to comply with can lead to appropriate sanctions against my facility as they deemed fit.
